

entering and exiting, schools and daycare centers are places for bed bugs to be transported to and from. Protocols should

be established to deal with bed bugs when they appear.

Unlike apartment buildings, homes and hotels, schools are not as likely to develop breeding populations of bed bugs because the bugs feed exclusively on blood taken from a person asleep or at rest. In contrast, daycare centers may be more likely to develop serious bed bug problems in rooms where children nap.

Having guidelines for preventing and handling bed bugs if and when they appear is critical to reducing bed bug problems.

Recommended Guidance

- Collect any specimens thought to be bed bugs. Place them in a small container of isopropyl (rubbing) alcohol. Have specimens identified by a qualified individual such as an entomologist or pest management professional. Remember that finding a confirmed bed bug on a child or child's belongings does not necessarily mean the child's household, or the school or daycare, is infested.
- Discretely remove the child from the classroom and inspect his/her clothing and belongings along with any bins or lockers used to store the child's belongings. To kill all stages of bed bugs, clothing and other items can be dried in a hot dryer for at least 20 minutes.
- After inspection, keep potentially infested belongings in a tightly sealed container such as a garbage bag or plastic bin with lid. Leave them there except when they are needed or when the child leaves for home.

- Send bed bug information home with the child to inform parents or guardians that the home may be infested. Include material about bed bugs and how they are controlled, including the need for professionals to confirm and control bed bug infestations. Also consider sending information home with children who may have come in contact with the child or the child's belongings.
- Where it is confirmed or reasonable to believe that bed bugs may be infesting a school or daycare, call a pest management professional or a staff member who has knowledge of and experience with bed bugs, to inspect all rooms visited by the child and the child's belongings. Rooms where bed bugs occur should be treated to eliminate the bugs. NOTE: It is unlawful to apply most pesticides in public schools and daycare centers with children present. Staff should not be permitted to bring and use pesticides in the facility. Applicators must be familiar with Integrated Pest Management (IPM) regulations.
- Infested households should employ a pest management professional and take precautions to prevent transporting bed bugs to schools, daycares or other facilities. At home, clothing to be worn outside the home should be washed and dried in a hot dryer for at least 20 minutes, then placed in a tightly sealed container such as garbage bag or plastic bin until just before the child exits the home. This also applies to personal items such as coats and backpacks.

What are bed bugs?

Bed bugs are small, brownish, flattened insects that feed on the blood of people while they sleep. Although the bite does not hurt at the time, it may develop into an itchy welt similar to a mosquito

bite. Bed bugs do not transmit disease, but they can cause significant itchiness, anxiety, and sleeplessness. Bed bug infestations are also very difficult and expensive to control.

Usually, bed bugs will hide during the day and only come out to feed during the night. Unlike head lice, they do not live on a person. However, they can hitchhike from one place to another in backpacks, clothing, luggage, books, and other items.

Could my classroom be infested?

Actual bed bug infestations in schools are uncommon. More commonly, a few bed bugs will hitchhike to school from an infested home by hiding in a student's clothing or backpack. Bed bugs that hitch a ride into the school in one student's backpack could be carried home by another student, making the school a potential hub for bed bug spread. This is not a minor concern – bed bugs are very expensive and difficult to eradicate.

If a school plans to use pesticides to control pests indoors, then they are required under Indiana law to have an integrated pest management (IPM) plan in place. If a bed bug infestation is suspected or a number of students are getting bitten during class, the school should contact a licensed pest management professional for assistance.



What can I do to eliminate bed bugs from my classroom?

DO NOT allow untrained staff to apply pesticides on school property. By law, only IPM trained applicators can apply pesticides (even ready-to-use products like sprays) in schools, and in compliance with the school's IPM plan.

Backpacks, lunchboxes, and other items that travel back and forth to school can also be inspected daily and sealed in plastic containers to prevent bed bugs.

Hard surfaces can be cleaned with standard cleaning products.

If bed bugs have been found repeatedly in a particular classroom, have the room inspected by a pest management professional or other trained staff.

What if I find a bed bug on a student?

If a bed bug is found on a student, it may indicate that the student has bed bugs at home. However, bed bugs can crawl onto or off a person (or their belongings) at any time, so it is also possible that the bed bug was brought to school by someone else. If a suspected bed bug is found on a student or a student's belongings, the following procedures should be followed:

- The student should be discreetly removed from the classroom so that the school nurse or a qualified individual can examine the student's clothing and other belongings. Any bugs found should be removed and collected for identification. Try to keep the specimens as intact as possible.
- If a confirmed bed bug was found on a student, then the school principal or nurse should contact the student's parents or guardian to inform them of the bed bug presence on their child. Consider sending a bed bug inspection form home, a sample is provided at the end of this document. Educational materials, such as those available at the Indiana Department of Health (IDOH) Health: Infectious Disease Epidemiology & Prevention Division: Bed Bugs should also be provided to the family.
- The school principal or nurse or center program director should consider notifying the affected class or classes. A sample notification letter is provided at the end of this document.
- Students should not be excluded from school due to bed bugs unless repeated efforts have been made to remedy a bed bug infestation. Schools should not be closed due to bed bug presence, if pest management is necessary, it will normally be targeted to certain areas of the school.
- Ongoing pest management that includes the use of pesticides indoors should be overseen by the school principal or designee and must conform to the school's integrated pest management plan, as required by <u>Indiana law (357 IAC 1-16)</u>.

What if one of my students has an infestation at home?

When a student is dealing with an infestation at home, it is important to be sensitive to their problem. Although bed bugs have nothing to do with cleanliness or socioeconomic status, there is still a stigma that can come with having bed bugs. As a result, parents may be hesitant to admit to having bed bugs, and students may not want others to know they have an infestation at home. Students living in an infested home may also feel anxious or tired during the school day. Schools should work with the parents of any student living in an infested home to develop strategies for preventing the further spread of bed bugs.

- Determine if the infested home is being treated. Home remedies and do-it-yourself treatments are usually insufficient and could cause negative health effects or produce potential hazards in the home.
- If a parent lacks the financial resources to hire a pest management professional, they can reach out to the following social service agencies for assistance:
 - ✓ <u>Greene County Division of Family Resources</u>: They can provide information and possibly connect families with resources for dealing with bed bugs. Their office is located at 104 County Road 70 E., Suite D, Bloomfield, IN 47424. You can contact them at 800-403-0864.

 - ✓ Pace Community Action Agency: They offer a variety of services including outreach, advocacy, and information & referral to help meet the needs of disadvantaged individuals and families. They are located at 21 E Main St, Washington, IN 47501. You can contact them at (812) 254-69361.
 - ✓ <u>Western Indiana Community Action Agency</u>: This nonprofit organization provides human and social services, including assistance with food security, housing, and more.  - ✓ <u>New Hope for Families</u>: Although based in Monroe County, they provide emergency shelter and support services for families, which might be helpful if you're in a neighboring area. They are located at 1140 S Morton St, Bloomington, IN 47403. You can reach them at (812) 334-9840.
 - AccessAbilities: While primarily focused on assisting individuals with developmental disabilities, they may offer guidance or referrals for pest control services. They are located at 1711 N College Ave, Bloomington, IN 47404. You can reach them at (812) 323-46602.
 - ✓ Youth Services Bureau of Monroe County: They provide various support services and might be able to offer advice or referrals for bed bug issues. Their address is 615 S Adams St, Bloomington, IN 47403, and their phone number is (812) 349-25063.

- In an infested home, parents should store their child's freshly laundered clothing in sealed plastic bags until they are put on in the morning. This prevents bed bugs from hiding in their clothing and being carried to school.
- Backpacks, lunchboxes, and other items that travel back and forth to school can also be inspected daily and stored in sealed plastic containers at home to prevent bed bugs from getting into them.
- At school, the student could be provided with plastic bags or bins in which to store their belongings to prevent any bed bugs from spreading to other students' belongings.
- If bed bugs are finding their way into the school, consider notifying the affected classes. A sample notification letter is provided at the end of this document.
- Continue to use these measures until successful treatment of the home has been verified



Bed Bugs Found in a Classroom Parent Notification Letter

(Use appropriate school letterhead)

Dear Parent or Guardian:

We recently found a bed bug in your child's classroom. Bed bugs are a nuisance, but their bites are not known to spread disease. Bed bugs are usually active at night and feed on human blood. The bite does not hurt at first, but it may become swollen and itch, much like a mosquito bite. Watch for clusters of bites, usually in a line, on exposed areas of the body. If you have medical concerns for you or your child, please contact your doctor.

The source of bed bugs often cannot be determined, as bed bugs may be found in many places including hotels, planes, and movie theaters. Even though it is unlikely for bed bugs to infest a school (fill in your school district here) will conduct an inspection and, if needed, will implement an integrated pest management plan in the area where the bed bug was found. (Fill in your school district here) will continue to work to identify bed bugs, provide thorough inspections of schools, and have licensed pest control specialists assist with pest management.
